This policy sets out how we process any personal data we collect from you or that you provide to us through our website and collected manually. - **Information gathered by**, Google Analytics and Bing Webtools to include but not limited to; browser type; devices; visits; time on site; heatmaps etc.

How we may use the information we collect

Information you supply to us. We will use this information:

Information we automatically collect about you. We will use this information:

- to administer our site including troubleshooting and statistical purposes;
- to improve our site to ensure that content is presented in the most effective manner for you and for your computer;
- security and debugging as part of our efforts to keep our site safe and secure.

This information is collected anonymously and is not linked to information that identifies you as an individual. We use Google Analytics to track this information. Disclosure of your information

Any information you provide to us will either be emailed directly to us. We use a trusted third party website and hosting provider (123 Reg) to facilitate the running and management of this website. 123 Reg meet high data protection and security standards and are bound by contract to keep any information they process on our behalf confidential. Any data that may be collected through this website, is kept secure and only processed for personal contact and student education purposes.

We do not rent, sell or share personal information about you with other people or non-affiliated companies.

We will use all reasonable efforts to ensure that your personal data is not disclosed to regional/national institutions and authorities, unless required by law or other regulations.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.
